Wedding Photography Terms & Conditions

It is mutually agreed that the following terms of agreement form an integral part of this contract and that no variation or modification of this contract shall be effective unless accepted by both Victoria Dolman Photography and the Client, in writing.

BOOKING FEE & PAYMENT

A non-refundable booking fee of £100 is required at the time of the Wedding Booking in order to secure Victoria Dolman Photography's services. The remaining balance for all Wedding Photography Packages will then be due for payment 4 weeks prior to the Wedding Event. Payment may be paid by cash, cheque or bank transfer. Please make cheques payable to Victoria Dolman.

WEDDING BOOKING SERVICES

Victoria Dolman Photography requires a £100 Booking Fee payable at the time of booking to secure Victoria Dolman Photography's services. Victoria Dolman Photography only covers one wedding per day.

Each Wedding Photography Package provides the client with photographic coverage of the wedding day event, as specified but not limited to the Package Description. Each Client's individual requirements will be discussed prior to the Wedding Event and Victoria Dolman Photography will endeavour to accommodate the Clients requests regarding photography as appropriate.

Victoria Dolman Photography will then provide the client with a high resolution DVD or DVD's of all the edited images as outlined in the Package Description.

PRICES

Prices are set by Victoria Dolman Photography and may be changed without prior notification. Should a Wedding Booking be made prior to a pricing amendment, the prices at the time of Wedding Booking will be honoured. Prices for individual prints, digital images, gift products and canvases are all listed on our website for reference.

CREATIVE LICENCE

Victoria Dolman Photography shall be granted creative and artistic licence in relation to the choice of locations and poses used. Victoria Dolman Photography's judgement on photographic style and the number of photographs taken shall be deemed correct. Some photographs may not be possible due to changes in the weather and the availability and willingness of subjects. Victoria Dolman Photography will do their best to honour any requested photographs by the client but cannot guarantee to undertake any specific picture nor incorporate any specific background, location or group arrangement.

For bookings involving a church ceremony or at certain other venues, photographers' movements are sometimes restricted by the minister or official in charge: photographing of parts or even all of the ceremony may be restricted or prohibited, as may the use of artificial lighting. Victoria Dolman Photography cannot accept responsibility for limited photographic coverage in such cases.

COPYRIGHT

The 1998 Copyright, Designs, and Patents Act assigns copyright to Victoria Dolman Photography. You may not copy the photographs taken under this contract, or allow copies to be made photographically, electronically, or by any other means, without the permission of the Photographer in writing. It is understood, however, that if a DVD of said images is purchased as part of this contract, that the Client(s) will have the right to reproduce the images therein for personal use only and not for distribution of any kind.

DISPLAY

The Clients hereby agree to allow Victoria Dolman Photography to display any images covered under this booking and to generally promote the business by means of advertising, publicity material, websites, exhibitions, competitions, magazine articles and other such media, providing that the images are used lawfully and without damage to the clients.

Through the provision of a private online gallery, the client will also have access to view all the photographs from the wedding event which is accessible through www.victoriadolmanphotography.co.uk. Whilst measures are taken to keep the gallery private and secure, Victoria Dolman Photography cannot be held responsible if other persons gain access the files without permission.

COLOUR MATCHING

Victoria Dolman Photography will provide a pleasing colour balance but cannot guarantee an exact colour match owing to anomalous reflectance caused by a combination of certain dyes and materials, especially man-made fibres. It is sometimes impossible to record by digital capture the exact colour as seen with the human eye.

DIGITAL IMAGING

Due to the limitations of computer monitors it is understood that images may appear differently according to the specification of each monitor and that prints will not match images rendered on any particular computer monitor.

Victoria Dolman Photography uses only quality branded DVDs for digital image files, ensuring each DVD is checked before dispatch. It remains the client's responsibility to check discs for in-transit damage. Victoria Dolman Photography cannot be held responsible for damage to equipment resulting from defective media.

FORCE MAJEURE

In the unlikely event of total photographic failure, injury or sickness beyond Victoria Dolman Photography's control, their liability shall be limited to a full refund of all monies paid. Your statutory rights are not affected. Victoria Dolman Photography has full Public Liability and Professional Indemnity Insurance.

CANCELLATION OR AMENDMENTS TO WEDDING BOOKING

If the Client wishes to make any amendments to the wedding booking (such as change of ceremony date, time or venue), this needs to be done in writing and communicated to Victoria Dolman Photography at the Clients earliest convenience. Victoria Dolman Photography will endeavour to accommodate these changes, however should Victoria Dolman Photography be unable to accommodate the amendments requested Victoria Dolman Photography are not liable to compensate the Client in any way whatsoever.

Should the Client wish to cancel the Wedding Booking this must be done so in writing; sent to Victoria Dolman Photography. If cancellation is made 12 weeks or more before the intended wedding date, the client will owe no further monies and the contract will be deemed cancelled.

For a wedding cancelled less than 12 weeks and more than 4 weeks before the wedding date, 25% of the final balance payment will be due. If the booking is cancelled less than 4 weeks prior to the intended wedding date, 50% of the final wedding payment will be due, if full payment has already been received Victoria Dolman Photography will refund 50% of the final balance payment.

COMPLAINTS PROCEDURE

Please address any complaints to Victoria Dolman Photography by email or telephone as per our contact details. We will endeavour to respond to any complaint within 2 working days of receipt.

GOVERNING LAW

The contractual relationship between Victoria Dolman Photography and the Client shall be governed by the Laws of England.
